The Directors of Scottish Midland Co-operative Society are pleased to present their interim report to members.

With the benefit of very favourable weather conditions for our food convenience business, the Society delivered a strong half year performance despite a very unforgiving retail market. In the 26 weeks ended 28 July the Society's trading profit was £2.3m, 16% up on the equivalent period last year. This positive result was achieved in a period when the Society continued to face significant external cost increases. Trading turnover increased by £3m to £184m and the Society's balance sheet strengthened further with the net asset base now in excess of the f100m mark.

Despite externally imposed cost increases. the Society's food convenience business performed well with turnover growth driven by the favourable weather and the continued rollout of food-to-go. The background trading conditions for our Semichem stores were very difficult but the trading result improved at the half year because of action taken to reduce costs. Progress was also made with the trial of new store concepts. Scotmid Property continued to benefit from the net investment in our property portfolio. Funerals had a very strong half year result with a gain in market share

Development of the Society's community activity in the period included the roll out of Community Connect into the East membership

region and other high-profile support for community wide organisations such as the Erskine Hospital, St Andrews First Aid, Great North Air Ambulance and the Social Bite Village. Community Connect also assisted the democratic membership activity with increased member engagement and attendance at our member meetings.

At the year-end we highlighted the cloud of an uncertain Brexit and that 2018 was likely to be yet another difficult year for retailers generally. This prediction has been confirmed with a large number of high street retailers hit hard by market issues and an increased probability of a "no deal" Brexit. At the half-way point the Society has performed strongly despite the very challenging general market conditions with the benefit of exceptionally supportive weather for our food retail business. Clearly we must be cautious when assessing this performance, but the background work on differentiation and cost efficiency measures has continued to underpin a favourable underlying result. The likely return to more normal weather will make the second half of 2018 more challenging. The Society will therefore continue to focus on innovation (including Semichem trials), effective investment and tight control of costs to continue to make progress in this unforgiving retail market

FOOD RETAIL

In the first half of 2018, Scotmid's food convenience stores performed very well, assisted by the positive impact of the most extreme weather seen in Scotland for decades. Shoppers preferred to shop locally during the "Beast from the East" so our stores benefitted significantly during the snow. However the weather also severely disrupted the Coop supply chain resulting in a relatively slow recovery in a number of our stores. The summer period was one of the warmest experienced for the past 40 years. During the prolonged hot and dry weather the supply chain held up well and the business achieved record weekly sales over a sustained period.

The strategy of differentiation through the development of "food-to-go" continued, but with the benefit of the hot weather it was the key convenience categories and summer favourites that further boosted sales to deliver comparable turnover growth significantly ahead of the Scottish market. Minimum Unit Pricing of alcohol was introduced in Scotland in May, however with the glorious summer and the benefit of the 2018 World Cup, it has been difficult to draw conclusions about the impact of this new legislation.

With significant rises in the National Living Wage, business rates and utility costs, tight cost control and the benefit of efficiency

measures have been important to the delivery of the positive half-year result. The Society's "make it simple" project continued with further investment in both capital and process improvement to reduce unproductive store task.

The first half of 2018 saw continued investment in the store estate with refits completed at East Calder, Moredun. Bankton and Uddingston. A new look and feel has been trialled in these stores which includes new Scotmid branding, signage and colour palette. The fit out style has been refreshed with an expanded range of food-to-go products, new LED lighting and energy efficient refrigeration cabinets. The cabinets have the latest technology built-in and are supplied by refrigeration plant which is managed by a control system and run on a natural refrigerant (CO2). In addition, the equipment required to expand the range of food-to-go products was rolled out to more stores and revamp of the "Kitchen" stores was completed.

On 1 July Kevin Plant was confirmed as the new Head of Scotmid Food. Kevin was previously the Head of Food Operations after holding a similar role with Semichem. The success of the Society's food business was recognised externally with the HIM Awards' Favourite Food-to-Go Retailer 2018.

A new look and feel has been trialled which includes new Scotmid branding, signage and colour palette. The fit out style has been refreshed with an expanded range of food-to-go products, new lighting and energy efficient refrigeration cabinets.



SEMICHEM

Market factors such as economic and political (Brexit) uncertainty coupled with structural changes in the retail industry have had a particularly damaging impact on non-food retailers. More names have disappeared from the high street and there has been an increase in CVAs (Company Voluntary Arrangements) across the retail sector. Unlike food retail, the change in customer shopping behaviour during the extreme weather in the first half of 2018 was generally unhelpful for non-food retailers. Semichem also felt the impact of lower consumer confidence in Northern Ireland and a reduction in cross-border trade. Against this very unhelpful market Semichem background. delivered improved half-year result. This was achieved by the tight management of the cost base, closure of loss making stores and a reduction in business rates that helped to offset a decline in sales.

As part of continuous improvement activity and to build on the first trial at Bathgate, trials were launched in a further nine stores featuring some specific individual elements of the original Bathgate model. These included separate testing of the impact of new store layouts, category space allocation, range consolidation and new ranges. A further key development was the recent launch of the first two SC Beauty stores – in Johnstone in the West of Scotland and Foyleside in Northern Ireland. These trial concept stores have a greater emphasis on cosmetics, skincare and health and beauty products and will enable a test of a potential alternative way forward for Semichem as part of a sustainable long-term model.

Other store development work included minor refit works at Newton Stewart, Coatbridge, Castle Douglas and Larne. The warehouse IT system was upgraded in the period with a number of benefits for both warehouse and stores and a lease extension for our depot at Livingston was secured.

On 1 July, Karen Scott was appointed as the new Head of Semichem, Karen has been promoted internally from within the Society after successfully developing through a number of roles in retail and central support services



PROPERTY

Scotmid's Property business posted another record surplus for the first half of 2018 driven by improved rental income during the period. Despite the continuing uncertainty around Brexit, the residential and commercial property markets have remained relatively robust. The notable exception is commercial retail property with several high profile non-food retailing failures and CVAs occurring including Poundworld, New Look, The Original Factory Shop and House of Fraser. The Society recognises the risk associated with the retail property sector and has continued with the long-standing Society strategy of diversification and reinvestment in other property categories.

Despite a lease expiry for a significant tenant, underlying commercial rental income increased in the first half due to successful re-investments, new lettings and lease renewals. Residential rental income grew year-on-year and this was achieved through new investment, rental growth and reduced voids.

The level of demand for quality private rented accommodation remains strong, keeping voids low and modest rental growth continues to be enjoyed. Some fundamental changes to residential tenancy law in Scotland were introduced in late 2017 for which the Society was well prepared and these have not had any discernible impact on the business.

Other development activity in the period included the acquisition of a development site in Drumnadrochit and commencement of construction of a new Scotmid food store (relocation) and four adjacent units for complimentary letting. The build is scheduled for completion in early 2019.

FUNERALS

Scotmid Funerals recorded a strong performance in the first half of 2018 driven by a significant increase in funeral numbers compared to a difficult first half last year. As a result the Society saw positive growth in market share.

Competition in the marketplace continues to grow together with a focus on affordable funerals. The Society remains committed to transparency of pricing including the recent introduction of a 'Cremation Without Ceremony' option.

Scotmid Funerals' strategy for organic growth for the funeral business continued with the opening of the Clermiston office in Edinburgh earlier this year. The Society also continues to play an important role within industry organisations and these include membership of the Scottish Working Group on Funeral Poverty, representation at the Scottish Parliament, engagement with the Scottish Government on the Burial & Cremation Act (Scotland) 2016 and the devolution of Social Security powers which includes the Social Fund Funeral Payment.



SUPPORT SERVICES & OTHER SOCIETY MATTERS

In 2018 to date, central teams have provided support for a number of the Society's business development and continuous improvement projects.

The "Make it Simple" project has continued the drive to simplify and automate store processes with the intelligent counter cache solution deployed to a further 28 food stores - now in 154 stores in total. Process improvements, such as one-click compliance documentation printing and a simplified range review process were trialled, proven and rolled out. The processes and till developments to support Minimum Unit Pricing were successfully developed and implemented and a new touch screen handheld device for Food stores has been selected. In addition the design and testing of new store back office computers has been completed which will enhance the stores' cyber security profile.

Support teams completed preparation work for the introduction of the General Data Protection Regulation legislation (GDPR). All relevant documentation was assessed and where necessary amended, all our customer facing websites were updated with new

privacy statements. In the first half of 2018 agreement was reached on a new deficit recovery plan for the Society's retirement cash balance pension scheme based on the results of the actuarial valuation at January 2017.

Following the Administration of Conviviality Plc, the retail part of the business was bought by Bestway. Franchise stores in Scotland are not currently their priority given market differences like minimum unit pricing, licensing and volume promotional restrictions. The trial in Scotland has therefore been postponed and our Bargain B's trial stores in Troon, Stevenston and Annan have been closed.

The Society's surplus before tax at the half year was £0.9m, £0.4m down on 2017. This reduction was largely due to lower one-off profits from the sale of investment property which last year included proceeds from the sale of Morningside Road in Edinburgh. The Society's net asset base grew to £100.5m (pre-tax), the first time in the Society's history it has exceeded the £100m threshold and positive cash flow of £1.9m was generated in the first half of the year.

MEMBERSHIP & COMMUNITY

The development of the Society's community activity continued with the rollout of Community Connect into the East membership region. The good cause groups that received funding of £15,000 for projects in the last round were North Member Region's Highland Cycle Ability Centre and West Member Region's Street Connect. Other significant community support and donations included the Great North Air Ambulance, GIST Support UK, Erskine Hospital, the Social Bite Village and St Andrew's First Aid. Demand for Scotmid's Community Grants has also increased following the success of the Community Connect Scheme enabling additional support to be given to our local communities.

Community Connect also had benefits for the Society's democratic member activity with increased member engagement, enhanced attendance at member meetings and greater media coverage. Preparation work for a thorough cleanse of the Society's member database was also completed. The Jigsaw magazine continues to provide an effective way for the Society to connect to its membership and the latest issue was well-received and included features on local suppliers, in-store tasting events and information on GDPR and how it affected members. The Society would to like record

its thanks to John Anderson who retired from the Scotmid Board after 20 years of service to the Society and over 50 years to the Co-operative movement. At the North AGM on 1 May, Richard McCready was elected to replace John and we also welcomed four new elected members on to our Regional Committees.

The Society's members, colleagues and customers raised £315,000 during the year for our Charity of the Year, Samaritans. The funds raised will help fund 63,000 contacts from people needing support. The Scottish SPCA, RSPCA and USPCA were announced as the Society's new Charities of the Year, with an exciting range of activities planned throughout the year and funds raised dedicated to the charities programme aimed at educating primary schoolchildren across the country about animal welfare.

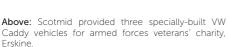
